Limited nursing services or mental health services are also provided if the facility is licensed to do so.

Foster/Elderly/Handicapped - Group homes in single-family structures that provide supervision and care necessary to meet the physical, emotional & social needs of its residents.

These structure include foster care homes as well as facilities for the elderly and handicapped.

ALF - assisted living facilities

## An Inventory of Group Homes Licensed by the Florida Department of Children and Families

Under 9J-5.010(1)(e), F.A.C., the Housing Element must have “an inventory of group homes licensed by the Florida Department of Children and Family Services, including the type, number, generalized location and capacity.”

### What constitutes a “Group Home”?

Under 9J-5.003(53), a “group home” means “a facility which provides a living environment for unrelated residents who operate as the functional equivalent of a family, including such supervision and care as may be necessary to meet the physical, emotional and social needs of the residents. Adult congregate living facilities comparable in size to group homes are included in this definition. It shall not include rooming or boarding homes, clubs, fraternities, sorities, monasteries or convents, hotels, residential treatment facilities, nursing homes, or emergency shelters.”
